decision against him has withdrawn it after learning that the tendering process has been cancelled and was now under special audit of the Public Procurement Regulatory Authority

The event is designed for all public procurement stakeholders, including board members, accounting officers/delegated account officers of public institutions, councillors, tender board members, procurement and supplies professionals in

public and private sector, legal officers, internal auditors and heads of user departments. The forum is also meant for bidders, civil society organizations, as well as students from higher learning institutions pursuing procurement courses.

Invitees will be required to pay a participation fee of TZS 500,000/=, and they are required to confirm their participation through tsms.ppra.go.tz before 30th April, 2022.

Bidder withdraws appeal as PPRA conducts special audit on tender

an administrative review of Permanent Secretary, President's Office Regional Administration and Local Government (PO-RALG) challenging the reasons they cited in disqualifying his tender for supply, installation, commissioning and maintenance of medical equipment for health facilities in Tanzania Mainland.

According to PPAA's ruling made under Justice (rtd) Sauda Mjasiri on 4 April 2022, Kastipharm Limited was aggrieved that the entity, which had advertised the tender through the Tanzania e-Procurement System (TANePS), made a decision to disqualify ten bidders, including the appellant, on faulty grounds as failure to attach tax clearance certificate was irrelevant – an assertion which was dismissed by the entity, leading to the appeal.

Of significance is the fact

that during the appeal hearing, the entity conceded that the tax clearance certificate was indeed not amongst the requirements in the tender document but that it was a requirement of TANePS. The appellant was adamant that there should be no additional requirement or instruction through TANePS, which is not part of the tender document but a web-based system that facilitates public procurement.

However, in its reply, the entity still sought to justify the role of the system in the shaping of their decision to disqualify, by stressing that as it was the official mode of communication for public procurement processes, if it said a tax clearance certificate was needed, the tenderer should have understood it as a bona fide tender requirement.

It later emerged during the hearing, that in fact the tendering process had attracted many complaints, which prompted the entity to request that PPRA

conduct a special audit whose report subsequently recommended re-evaluation of the tenders.

Given the new situation which, apparently, the entity had not communicated to the appellant until now, the former went on to pray for stay of the tender, pending determination of the re-evaluation results which would then be made known to all tenderers. At this juncture, the appellant decided to pray for withdrawal of the appeal as it was deemed pointless – a request which was not objected to by the entity who neither pressed for costs.

In its ruling, the Appeal Authority granted the prayers of both parties and ordered the entity to inform all tenderers that the previous notice of intention to award the contract had been cancelled and that the outcome of tender process would be communicated once it was ready.

Majukumu ya wanaohusika na mchakato wa ununuzi

UNUNUZI, kama ulivyotafsiriwa katika sheria ya ununuzi wa umma, unahusisha njia na taratibu au michakato inayofuatwa na taasisi nunuzi katika kupata bidhaa, huduma na kazi za ujenzi

Njia za ununuzi zinazoweza kutumiwa na taasisi nunuzi ni zile za ushindani wa wazi, zisizo na ushindani, au zenye ushindani unaolenga wazabuni wachache. Taasisi nunuzi inaweza kupata bidhaa, huduma au kazi za ujenzi kwa namna ya kununua na kumiliki moja kwa moja au kukodi vifaa, mashine au mitambo na kupanga nafasi za ofisi katika majengo ya taasisi zingine.

Taratibu au michakato ya ununuzi inahusisha hatua za kutambua na kuelezea mahitaji, kupanga ununuzi, kuchagua na kualika wazabuni, uandaaji wa mikataba ya ununuzi, utoaji wa tuzo za mikataba na usimamizi wa mikataba.

Ili taasisi nunuzi iweze kufanya shughuli za ununuzi kwa kujitegemea, inapaswa kuwa na mamlaka ya kuidhinisha bajeti, afisa masuuli, bodi ya zabuni, kitengo cha ununuzi, idara tumizi, na kuunda kamati za ufunguzi, tathmini na majadiliano wakati wa mchakato wa zabuni, na kuunda kamati za ukaguzi na usimamizi wakati wa utekelezaji wa mikataba ya ununuzi.

Mamlaka, bodi, idara na kamati zinazohusika na ununuzi zinapaswa kufanya majukumu yao kwa kushirikiana lakini pasipo kuingilia au kukwamisha majukumu ya wengine, ili ununuzi ufanyike kwa

ufanisi (ndani ya muda na pasipo makosa katika nyaraka na hatua za ununuzi).

Katika makala hii tutajikita katika kuangalia majukumu ya mamlaka, bodi, idara na kamati zilizo ndani ya muundo wa taasisi nunuzi katika mchakato wa ununuzi.

A. Kupanga ununuzi

Ununuzi, kama zilivyo shughuli nyingine, unahitaji kupangwa ili uweze kufikia malengo ya ubora, gharama na muda.

Upangaji wa ununuzi huanza wakati wa kuandaa bajeti ya taasisi na mpango wa ununuzi. Mahitaji ya bidhaa, huduma na kazi za ujenzi yaliyotengewa bajeti na taasisi katika mwaka wa fedha husika ndiyo pekee yanayopaswa kuingizwa kwenye mpango wa ununuzi. Mpango utaonyesha zabuni zote za bidhaa, huduma na kazi za ujenzi; mpango wa ndani utaonyesha bajeti kwa kila zabuni; njia za ununuzi; na tarehe kwa kila hatua ya mchakato wa zabuni kuanzia kutangaza mpaka kusaini mkataba wa ununuzi.

Uandaaji wa bajeti huusisha idara zote, uandaaji wa mpango wa ununuzi huratibiwa na kitengo cha ununuzi.

Kabla ya kuutangaza mpango wa ununuzi, hutakiwa kibali cha mamlaka ya kuidhinisha bajeti. Pale ambapo taasisi inataka kuboresha mpango wake wa ununuzi, kibali cha afisa masuuli hutakiwa.

Wakati wa utekelezaji wa ununuzi, upangaji wa ununuzi utahusisha uchaguzi wa nyaraka, njia za ununuzi na mikataba ya kuingia na wazabuni. Kitengo cha ununuzi kinapaswa kupendekeza nyaraka sanifu za zabuni na njia za ununuzi zitakazowezesha kutimiza mahitaji ya idara tumizi; bodi ya zabuni ikiridhika na nyaraka na njia zilizopendekezwa, watatoa kibali ili zitumike.

Wanaohusika na upangaji

wa ununuzi ni idara tumizi zote, mamlaka ya kuidhinisha bajeti, afisa masuuli na kitengo cha ununuzi.

B. Kutambua, kueleza mahitaji na kuanzisha mchakato

Ni jukumu la idara tumizi kutambua na kuelezea sifa, ubora, idadi, mawanda, muda na gharama za bidhaa, huduma au kazi za ujenzi wanazohitaji zinunuliwe ili kutimiza majukumu yao katika taasisi nunuzi.

Hatua ya kutambua na kueleza mahitaji inaweza kufanyika katika awamu mbili: moja ni wakati wa kuandaa mpango wa ununuzi kutokana na bajeti ya taasisi, ambapo hapa idara tumizi inaweza kutambua na kueleza mahitaji kwa kiwango cha aina, idadi na gharama; mbili ni wakati wa utekelezaji wa ununuzi ambapo hapa idara tumizi anaweza kutambua na kueleza mahitaji kwa kina zaidi.

Idara tumizi inapaswa kutambua aina ya bidhaa wanayohitaji na kuelezea kazi zinazopaswa kufanywa na bidhaa husika, kisha ndipo wataalamu waweze kueleza sifa za kiufundi na ubora za bidhaa zinazohitajika. Idara tumizi wataeleza pia muda ambao bidhaa zinapaswa kuwasilishwa, mahali pa kuwasilisha na iwapo uwasilishaji utaambatana na huduma yoyote.

Idara tumizi inapaswa kutambua aina ya huduma inayotakiwa kutolewa na mtoa huduma, kisha kueleza lengo la kuhitaji huduma husika, shughuli za kufanywa ili kutoa huduma, viwango vya ubora vya utoaji huduma, muda wa kutoa huduma, eneo la kutolea huduma na bidhaa zitakazoambatana na utolewaji huduma.

Kwenye kazi za ujenzi, idara tumizi itapaswa kutambua kazi ya ujenzi inayopaswa kufanyika, kuelezea lengo la ujenzi husika, shughuli za kufanywa ili kukamilisha ujenzi, muda wa kukamilisha ujenzi, kuandaa michoro, makadirio ya aina

na idadi ya vifaa vya ujenzi na ubora wa vifaa vinavyohitajika.

Ili kukamilisha zoezi la kutambua na kueleza mahitaji idara tumizi itapaswa kukadiria gharama zote zitakazohusiana na uwasilishaji wa bidhaa, utolewaji wa huduma na ukamilishwaji wa kazi za ujenzi kulingana na viwango vya ubora na mahitaji ya ziada waliyoanisha.

Kama zoezi la kuandaa bajeti lilihusisha utafiti wa bei za soko kwa bidhaa, huduma na kazi za ujenzi zote zinazohitajika na taasisi nunuzi, gharama zilizomo katika bajeti zinaweza kutumiwa na idara tumizi kama makadirio ya gharama za ununuzi.

Wakati wa kutekeleza ununuzi, idara tumizi atatambua na kueleza kwa kina mahitaji yake ya ununuzi, atathibitisha kiwango cha fedha kilichotengwa au kinachopatikana kwa ajili ya ununuzi, kuomba ridhaa ya kununua kutoka kwa afisa masuuli na kuwasilisha hitaji lake la ununuzi kwenye kitengo cha ununuzi.

Aidha, idara tumizi itapaswa kuwasilisha maelezo ya vigezo vya tathmini vitakavyotakiwa kutumika ili kumpata msambaza bidhaa, mtoa huduma au mkandarasi mwenye sifa na uwezo wa kusambaza bidhaa, kutoa huduma au kukamilisha kazi ya ujenzi.

Kama idara tumizi siyo idara yenye utaalumu na mahitaji ya ununuzi, idara hiyo ni vema ikaomba msaada wa maelezo ya kiufundi katika kila hatua ya kutambua na kueleza mahitaji.

Wanaohusika na kutambua, kueleza mahitaji na kuanzisha mchakato wa ununuzi ni idara tumizi zote.

C. Kuchagua na kualika wazabuni

Baada ya kupokea mahitaji ya idara tumizi, kitengo cha ununuzi kinapaswa kuelewa aina, gharama,

viwango vya ubora, muda, pamoja na sifa za mzabuni anayehitajika kusambaza bidhaa, kutoa huduma au kukamilisha kazi za ujenzi, zinazohitajiwa na idara tumizi.

Kitengo cha ununuzi kinapaswa kupendekeza njia au utaratibu sahihi wa ununuzi kwa kuzingatia gharama za ununuzi au mazingira mengine kama ambavyo yameanishwa kwenye kila njia ya ununuzi.

Baada ya kupendekeza njia au utaratibu wa ununuzi, kitengo hicho kitapaswa kupendekeza nyaraka sanifu ya zabuni itakayowezesha kununua bidhaa, huduma au kazi ya ujenzi inayohitajika kwa masharti na vigezo yatakayolinda maslahi ya taasisi ununuzi. Nyaraka sanifu za zabuni zinapaswa kujazwa kwa kuwekewa taarifa za ununuzi husika, sifa za wazabuni waoweza kushiriki, vigezo vya tathmini, maelekezo ya namna ya kushiriki na maelezo ya kiufundi ya bidhaa, huduma au kazi za ujenzi zinazohitajika.

Maelezo ya kiufundi ya bidhaa, huduma na kazi za ujenzi na vigezo vya tathmini yanapaswa kuandaliwa na idara tumizi na kuwasilishwa kwenye kitengo cha ununuzi ili yajumuishwe na kuwa sehemu ya nyaraka ya zabuni itakayotolewa kwa wazabuni.

Kitengo cha ununuzi kitawasilisha mapendekezo ya njia au utaratibu wa ununuzi kwenye bodi ya zabuni, iwapo bodi ya zabuni wataridhika na mazingira yaliyopelekea mapendekezo ya njia na nyaraka ya zabuni, watatoa kibali.

Kwa kuzingatia njia ya ununuzi iliyoridhiwa na bodi ya zabuni, kitengo cha ununuzi kitaandaa tangazo au mwaliko wa zabuni na kuuwasilisha kwa afisa masuuli ili atoe mwaliko au tangazo la zabuni husika.

Tokea siku ambayo tangazo au mwaliko umetoka mpaka siku ya mwisho ya kuwasilisha zabuni, wazabuni wanaweza kuwasilisha zabuni zao. Kitengo cha ununuzi kitapendekeza majina ya watu watatu mpaka watano watakaounda kamati

ya ufunguzi wa zabuni, na afisa masuuli ataunda kamati hiyo. Kamati hiyo itafanya kazi ya ufunguzi wa zabuni zilizowasilishwa kwa mujibu wa maelekezo ya nyaraka ya zabuni; baada ya ufunguzi wa zabuni, hatua itakayofuata ni ya tathmini ya zabuni.

Kitengo cha ununuzi kitapendekeza kwa afisa masuuli majina ya watu watatu mpaka watano wa kufanya tathmini ya zabuni, baada ya uteuzi kamati hiyo itafanya tathmini ya zabuni kwa mujibu wa vigezo vya tathmini vilivyomo katika nyaraka ya zabuni, na kisha watawasilisha ripoti yao kwenye kitengo cha ununuzi.

Kitengo cha ununuzi kinapaswa kupitia ripoti ya tathmini na iwapo hawataridhika na tathmini ya zabuni basi, watarudisha ripoti hiyo wakianisha maeneo ambayo hawajaridhika nayo. Iwapo kitengo cha ununuzi kimeridhika na ripoti hiyo, wataandaa mapendekezo yao na kuyawasilisha pamoja na ripoti hiyo kwenye bodi ya zabuni.

Bodi ya zabuni watapitia mapendekezo ya kitengo cha ununuzi na kujiridhisha juu ya tathmini iliyofanyika, na iwapo hawataridhishwa, watarejesha mapendekezo na ripoti ya tathmini kwa mkuu wa kitengo cha ununuzi, wakimpa maelekezo ya maeneo yenye kasoro. Iwapo wameridhishwa, lakini wamekubali mapendekezo ya kufanya majadiliano yaliyotolewa na kamati ya tathmini, kitengo cha ununuzi au wao wenyewe, basi bodi hiyo itatoa ridhaa ya majadiliano kufanyika kwanza.

Kitengo cha ununuzi kitapendekeza kwa afisa masuuli majina ya watu watatu mpaka watano watakaofanya majadiliano na mzabuni anayependekezwa. Baada ya kuteuliwa na afisa masuuli, kamati hiyo inapaswa kuandaa mpango wa majadiliano na kuuwasilisha kwenye bodi ya zabuni. Baada ya mpango huo kuridhiwa na bodi, kamati hiyo itaendesha majadiliano kwa mujibu wa mpango huo, na kuwasilisha ripoti ya majadiliano kwa mkuu wa kitengo cha ununuzi. Hatua ya majadiliano siyo ya lazima

kwenye kila mchakato wa ununuzi, ila kama majadiliano yapo ni vema yakafanyika kabla ya bodi ya zabuni kutoa tuzo ya mkataba.

Wanaohusika na michakato ya kuchagua na kualika wazabuni ni kitengo cha ununuzi, bodi ya zabuni, kamati ya ufunguzi, kamati ya tathmini, timu ya majadiliano na afisa masuuli.

D. Kuandaa na kutoa tuzo ya mkataba

Baada ya majadiliano kukamilika, bodi ya zabuni inaweza kutoa tuzo ya mkataba kwa mshindi.

Kabla ya kuwasilisha mapendekezo ya kutoa tuzo ya mkataba kwa mshindi, kitengo cha ununuzi kwa kushirikiana na Idara tumizi wanapaswa kuandaa muswada wa mkataba pendekezwa na kuuwasilisha katika bodi ya zabuni pamoja na mapendekezo ya kutoa tuzo ya mkataba.

Baada ya bodi ya zabuni kufanya uamuzi juu ya mzabuni aliyeshinda, uamuzi huo unapaswa kuwasilishwa kwa afisa masuuli ili aweze kupitia mchakato mzima wa zabuni na kujiridhisha kama umezingatia matakwa ya sheria na kanuni.

Iwapo afisa masuuli hataridhishwa na mchakato huo, ataeleza sababu zake na kurudisha mapendekezo ya kutoa tuzo ya mkataba kwa bodi ya zabuni. Iwapo afisa masuuli ameridhishwa na mchakato, kwa upande wa serikali za mitaa, mkurugenzi atawasilisha taarifa kwenye kamati ya fedha na mipango kwamba anakusudia kutoa tuzo, kamati hiyo wanapaswa kujiridhisha iwapo ununuzi husika upo kwenye mpango wa ununuzi na kama mpaka wakati wa ununuzi kuna fedha za kugharamia ununuzi.

Iwapo hapakuwa na malalamiko ya wazabuni au kama yalishughulikiwa ipasavyo, afisa masuuli atatoa barua ya tuzo ya mkataba na kumwalika mzabuni mshindi kuwasilisha dhamana ya utekelezaji mkataba (kama inahitajika) ili waweze kusaini mkataba.

Wanaohusika na michakato ya kuandaa na kutoa tuzo ya mkataba ni kitengo cha ununuzi, bodi ya zabuni, idara tumizi, kitengo cha sheria na afisa masuuli.

E. Usimamizi wa mkataba

Usimamizi wa mkataba wa ununuzi unaanza baada ya mkataba husika kuwa umesainiwa na pande za mkataba, na kamwe barua ya tuzo ya mkataba haitaashiria kuanza kwa utekelezaji wa mkataba wa ununuzi.

Afisa masuuli ndiye mwenye jukumu la kwanza kuhakikisha kuwa kila mkataba wa ununuzi unatekelezwa kwa mujibu wa masharti na vigezo vya mkataba husika.

Idara tumizi ndiyo wenye wajibu wa kusimamia utekelezaji wa mkataba wa ununuzi ili uweze kukamilika kwa viwango vya ubora vilivyokubaliwa, kwa gharama zilizopangwa na ndani ya muda uliopangwa.

Ili kusimamia mkataba wa ununuzi vizuri, afisa masuuli anaweza kuteua mtu au timu ya watu watakaokuwa wakisimamia utekelezaji wa mkataba, lakini pia anaweza kuajiri mshauri elekezi ili kusimamia mkataba wa ujenzi.

Wasimamizi wa mkataba wanawajibu wa kuandaa ripoti za maendeleo ya utekelezaji wa mkataba kama ambavyo watakuwa wameelekezwa na afisa masuuli, bodi ya zabuni au kitengo cha ununuzi.

Maboresho yoyote kuhusu muda, gharama, viwango vya ubora au masharti ya mkataba, yanapaswa kupata ridhaa ya bodi ya zabuni kabla hayajatekelezwa.

Wanaohusika na usimamizi wa mkataba ni idara tumizi na afisa masuuli.
